WATER DISTRICT 74Q

The annual meeting for the year 1997, District 74Q was held on March 3, 1997 at 2 p.m. with five water users present: Bill Snyder, Bob Carlson, Scott Tyler, Tex Kauer, John Amonson and Secretary/Treasurer Judy Amonson.

Selection of a chairman and secretary/treasurer were considered. Bob Carlson made the motion that Bill Snyder remain as chairman and Judy Amonson remain as secretary/treasurer. Scott Tyler seconded the motion and it was carried.

There were no changes to the Credentials Committee consisting of Bob Carlson, Kent Bird, and John Amonson. The Advisory Committee consists of Bill Snyder, Dick Tyler, Bob Carlson and John Amonson. A report from Credentials Committee member John Amonson followed concerning the letter from the Water Resource Department of January 19, 1997, regarding ditch maintenance and locks. It was generally agreed that the installation of padlocks on the headgates could prevent tampering problems. Review and discussion on the current resolutions resulted in the addition of two new resolutions. John Amonson made the motion to add the two resolutions and Tex Kauer seconded the motion and it was carried.

Compensation to be paid to the watermaster and his assistant were reviewed and unchanged. Also discussed was the reduction of the fee for workman's compensation insurance for the year 1997.

The financial report was reviewed. The motion was made by Bob Carlson to adopt the proposed budget for 1997 and was seconded by Tex Kauer.

There was one applicant for the watermaster for this year. John Amonson made the motion to hire Dick Moll again for watermaster. Bob Carlson seconded the motion and all were in favor to pass the motion.

Meeting adjourned 4 p.m.
