SUBJECT: Appointment of District 43-C Watermaster for 1999

Orvil Wickel was the elected watermaster for this district last year. But he got too sick to perform his duties, so he appointed Laurie Darrington as deputy watermaster. She turned in a signed oath of office. The watermaster position for this district is a seasonal appointment, so a call-on petition signed by at least one water user is required before the watermaster can be officially appointed. We never received a call-on petition, so no appointment was made. We have now received a watermaster's report signed by Darrington. I discussed this with Advisory Board member Paul Ward, who felt that she did act as watermaster for 1999. He thought that it would be ok for me to approve her report, which I will do.

I REVIEWED THE CODE WITH TIM LUKE AND WE CAME UP WITH THREE OPTIONS:

1. HAVE ADVISORY BOARD RECOMMEND SOMEONE TO IDWR AND DIRECTOR APPOINT HIM. THIS IS STRETCHING 42-605.
2. HAVE WATERMASTER APPOINT DEPUTY WITH DIRECTOR'S APPROVAL THEN QUIT. THIS IS PURSUANT TO 42-609.
3. HAVE PETITION OR REQUEST FOR SPECIAL MEETING TO ELECT NEW WATERMASTER. THIS IS PURSUANT TO 42-605.

I CALLED STAN LLOYD BACK AND GAVE HIM THESE OPTIONS AND TOLD HIM TO LET US KNOW IN WRITING WHAT THEY WANTED. I TOLD HIM THE DEPARTMENT WOULD SUPPORT WHATEVER OPTION THEY TOOK.
