





Dear Mrs. Jones;

We have received the minutes of this year's water meeting. As you have again been elected as treasurer of your district, an oath of office is enclosed. Once we receive your notarized oath, a certificate of appointment will be issued.

I noticed that your district voted to assess a 20% penalty on late payments of water assessments. This amount is illegal under Sec. 42-617 of the Idaho Code, which limits penalties to 10% of the amount owed and interest of 1% per month. A copy of this statute is enclosed for your information.
