The meeting was called to order at 1:00 p.m. on March 9, 2009 at the Oakley Canal Co. office in Oakley, Idaho. The following members were Present: Richard Austin, Brandon Bedke, Will Bedke, Bruce Bedke, Jared Bedke, Michael Poulton, James Mullin and Kelly Adams. Again, there was no representation from IDWR. It would be helpful if IDWR would show interest in attending these meetings. They could answer concerns and help with direction.

The first item of business was the appointment of officers. The method of voting was by majority vote of the water users present. (Section 4, statute 42-605). Kelly Adams was reappointed secretary for the water year 2009. The minutes of the 2008 annual meeting were read and approved as written.

The budget was approved as the same budget as previous years. It was noted that since no money is collected the need for a budget is not required. The same goes for the need of a treasurer. It was deemed that the same resolutions adopted in the previous years be adopted for the water year 2009. This motion was accepted. Michael Poulton was re-nominated has the watermaster. This is to be a five year sentence and serves under the same terms and conditions as he did in the previous years.
