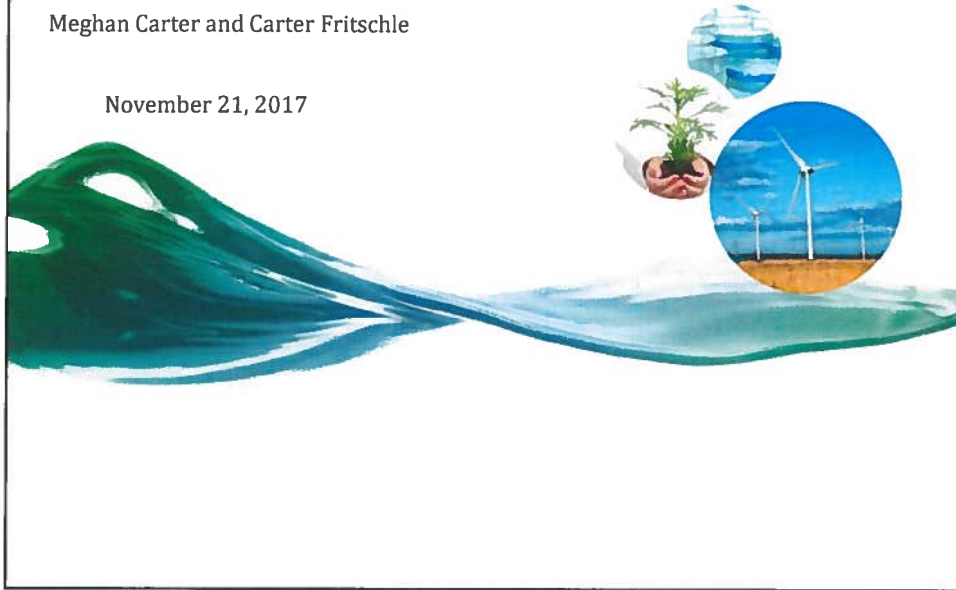

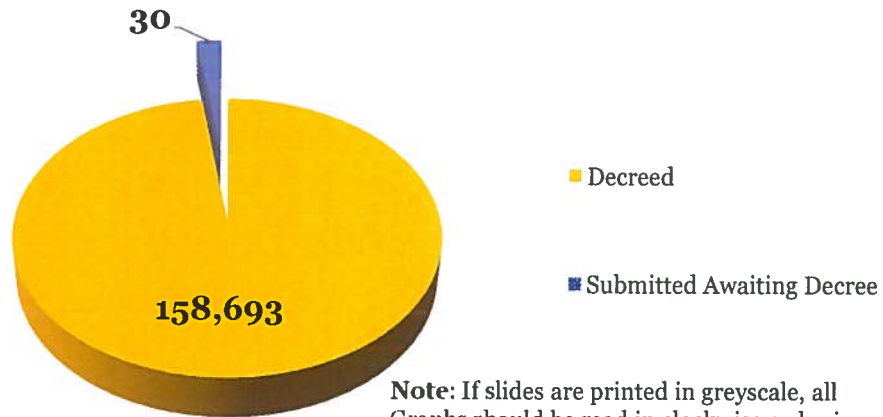

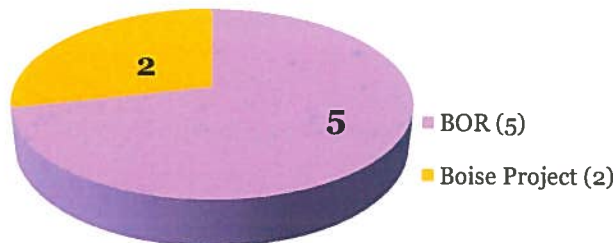
Counts of Water Rights

Reservoir Refill Objections to LCDR

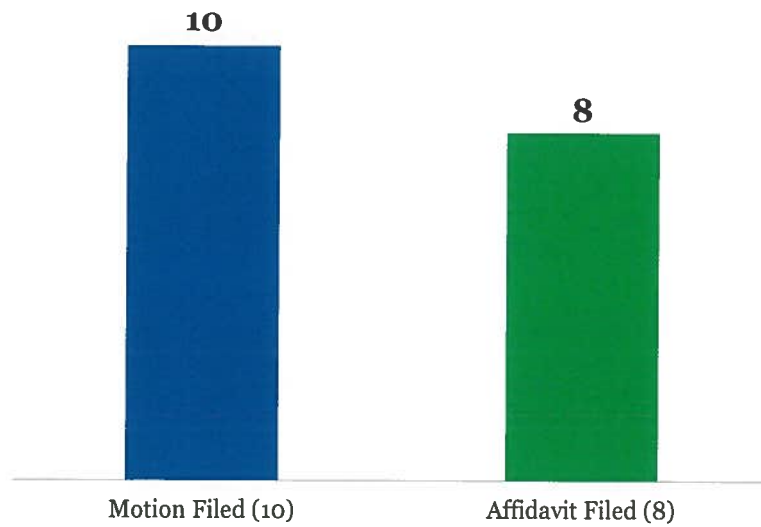

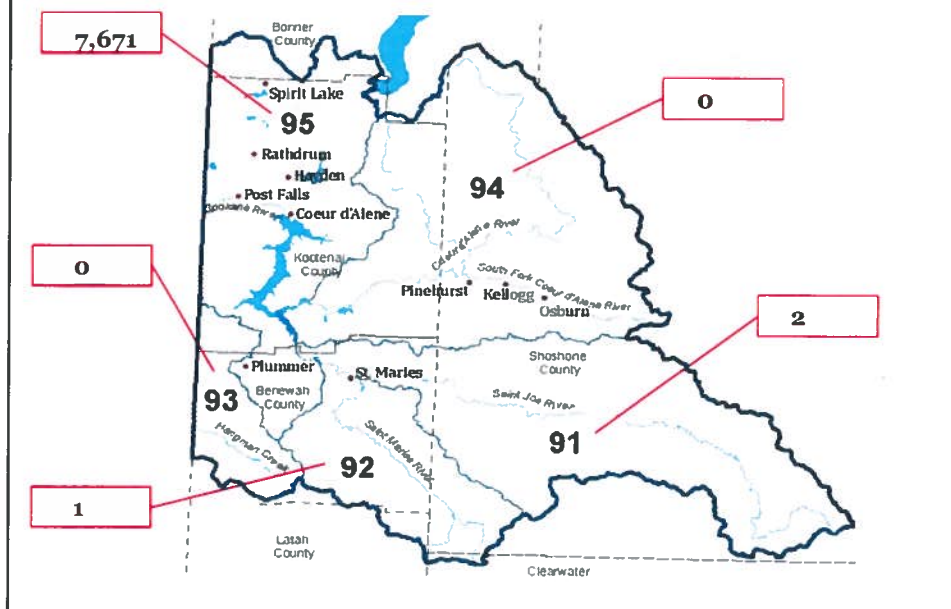

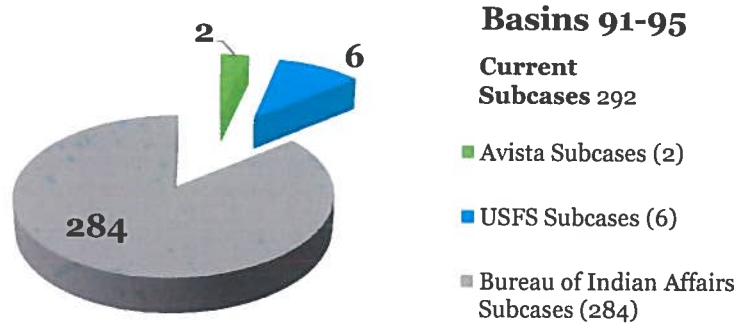

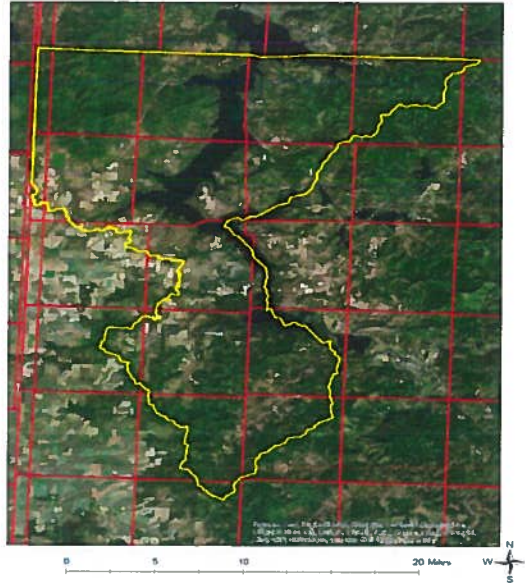
Current Status of Basin 95

- Preliminary DR will follow & DR, Part 2, fall 2018

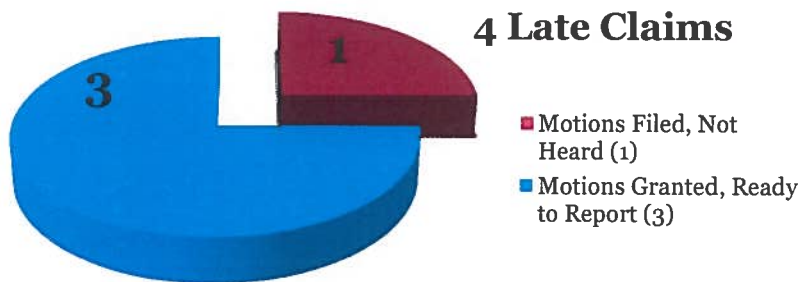
Basin 95 Part 1

Summary of Current CSRBA Late Claims





Update on the PRBA

- Petition to Commence General Adj. of Water Rights filed October 3, 2016
- Commencement Hearing on the Petition held January 18, 2017
- U.S. filed a Motion to File Stipulation for Establishment of Procedure for the Adjudication of de minimis claims D & S February 21, 2017
- On March 1, 2017, an Order Granting Motion to File Stipulation and Commencement Order was issued
- All federal claims to be submitted by December 2019.

1. Order Amending Procedures in the SRBA for Adjudication of Deferred *De Minimis* Stockwater Claims issued on October 17, 2017
