
Idaho Ground Water Appropriators, Inc. (IGWA), acting for and on behalf of its members, hereby petitions to intervene in this matter pursuant to Rules 350-354 of the Rules of Procedure of the Idaho Department of Water Resources.

Rule 350 authorizes intervention by anyone who claims “a direct and substantial interest in the proceeding.” IGWA has a direct and substantial interest in this matter because its members are subject to curtailment orders that require them to mitigate for impacts to the water supplies, including storage water, of various spaceholders in the Water District 1 reservoir system. If IGWA fails to provide sufficient mitigation water, its members’ water rights will be curtailed. Since the manner in which the Department accounts for storage may affect the amount of mitigation IGWA is required to deliver, IGWA has a direct and substantial interest in this proceeding.

Based on the foregoing, IGWA requests an order granting it intervention in this proceeding, for and on behalf of its members.


