**Re: Preliminary Order Revising Water District Nos. 170 and 73.**

Dear Water User,

Enclosed is a Preliminary Order Revising Water District Nos. 170 and 73. This action is take IDWR held a hearing concerning this matter on November 14, 2012 in May, Idaho. This order expands Water District No. 170 to include Idaho Department of Water Resources' (IDWR) Administrative Basin No. 73 and designates Water District No. 73 as a sub-district of Water District No. 170. Further, Water District No 73 will now administer water rights diverted from groundwater with the exception of those for small domestic and stockwater uses.

A sub-district is an organizational structure within Water District No. 170 that provides for users within that sub-district to select and fund a local watermaster to administer water rights in the sub-district. When Water District No. 170 was created, existing water districts in the area were designated as sub-districts within the larger district. Similarly, the existing Water District No. 73 is maintained for local administration as a sub-district of Water District No. 170. Although water rights within a sub-district are a part of Water District No. 170, the users within a sub-district control how the water district operates in their area. This is beneficial to the users as it provides a measure of local control, and it is beneficial to the water district as a whole in that it provides for consistent and effective administration of water rights through local expertise, while preserving the benefits of the larger water district.

Sub-district No. 73 will continue to meet annually for the purposes of electing a local watermaster, adopting a budget, etc. However, users in that sub-district may also attend the annual meeting for Water District No. 170, typically held the fourth Monday in January. A notice for the 2013 Water District No. 170 annual meeting is attached.

Attached also is an information sheet that explains options for responding to preliminary orders. Please note that any party subject to the order may file a petition for reconsideration within fourteen (14) days of the service date of the order, which is the date of this letter.

**PRELIMINARY ORDER**

The Director of the Idaho Department of Water Resources (“Director” or “Department”) is required by Idaho statute to divide the state into water districts for the purpose of performing the essential governmental function of distributing water among appropriators under the laws of the State of Idaho. *In re Idaho Dept. of Water Res. Amended Final Order Creating Water Dist. No. 170*, 148 Idaho 200, 211, 220 P.3d 318, 329 (2009). Idaho Code § 42-604 provides the Director with discretion in determining how these mandatory water districts shall be structured, allowing the Director to create new districts, revise existing districts, or even abolish districts, as the Director finds necessary for the efficient distribution of water resources. *Id.* Based upon the record in this matter, the Department finds, concludes and orders as follows:

**FINDINGS OF FACT**

1. Water District No. 73 is composed of the entire Pahsimeroi River drainage basin and is located in Custer and Lemhi Counties. Historically, Water District No. 73 has operated as an independent water district with its own watermaster. The watermaster has delivered and regulated water rights from the Pahsimeroi River and tributaries of the Pahsimeroi River. Ground water rights in the Pahsimeroi River drainage have not previously been adjudicated and have not been administered, measured, or assessed by Water District No. 73.

2. On April 6, 2006, the Director issued *Amended Final Order Creating Water District No. 170*.<sup>1</sup> The Order created Water District No. 170 to include all surface water and ground water rights in the Department’s Administrative Basins 71 and 72, other than de minimis domestic and stockwater rights as defined by Idaho Code §§ 42-111 and 42-1401A(11).

3. Finding of Fact No. 10 in the April 6, 2006 *Amended Final Order Creating Water District No. 170* refers to the Department's hearing notice proposing creation of Water District No. 170 and states, in pertinent part:

"The Director's notice also included a description of the Director's proposal to expand the Upper Salmon Water District by 2007 to encompass all of Basins 73, 74, and 75, after the water rights in those basins have been decreed by the Snake River Basin Adjudication (SRBA) District Court or included in one or more Director's Reports anticipated to be filed with the SRBA District Court in 2006, provided the SRBA District Court grants the Director authority for interim administration in those basins."

4. On April 19, 2010, the State of Idaho filed with the SRBA District Court a motion requesting an order authorizing the interim administration of surface and ground water rights (except those whose use is solely for domestic and/or stockwater purposes as defined under Idaho Code §§ 42-111 and 42-1401A(11)) by the Director in Administrative Basin 73. Copies of this motion were mailed to affected water right holders of record on or about April 19, 2010.

5. The State's motion for interim administration described in Finding 4 above states that "interim administration of water rights in Basin 73 is reasonably necessary because an efficient means of administering water rights from ground water sources and some surface water sources in the basin does not exist. The establishment or enlargement of water districts for this basin will provide the watermasters with the ability to administer water rights in accordance with the prior appropriation doctrine as established by Idaho law."

6. On May 21, 2010, the SRBA District Court issued an order authorizing the interim administration of water rights by the Director in Basin 73, pursuant to chapter 6, title 42, Idaho Code.

7. On October 30, 2012, the Director signed a notice proposing to modify Water District No. 73 to include administration of certain ground water rights and to modify the boundary of Water District No. 170 to include Water District No. 73 as a sub-district. The Director sent the notice of the proposed action by regular U. S. Mail to each holder of affected water rights within the boundaries of Water District No. 170 and Administrative Basin 73. The notice described the proposed district modifications, the reasons therefore, and the time and place for a hearing to be held on November 14, 2012 concerning the proposed district modification. The notice also provided a time period within which written comments on the proposed action would be accepted.

8. The notice mailed to water right holders proposed that the districts would be modified as follows:

- All water rights in administrative basin 73 shall be included in Water District No. 73, with the exception of de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113;
- The boundaries of Water District No. 170 shall be revised to include all surface and ground water rights in basin 73, other than de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113; and

- Water District No. 73 shall be designated a sub-district of Water District No. 170.

9. On November 14, 2012, at approximately 2:00 p.m. at the May Grange Hall in May, Idaho, Tim Luke, Water Compliance Bureau Chief for the Department conducted a hearing concerning the proposed modification of the districts. Approximately nine people attended the hearing.

10. The hearing officer initiated the hearing by explaining the hearing process. Department representative and Water District No. 170 watermaster Nick Miller gave a brief presentation that provided a general description of the proposed district modifications and reasons for the modifications. Reasons given for the proposed water district modifications included the following:

- Provide for administration of ground water rights within the Pahsimeroi River Basin, including measurement and reporting of ground water diversions;
- Integrate the administration and delivery of water rights tributary to the Upper Salmon River, including rights diverted from ground water sources. Integrated administration includes general oversight of all existing water districts (sub-districts) within the Upper Salmon Basin (currently limited to IDWR Administrative Basins 71 and 72), and tracking and regulation of new and future water rights within the Upper Salmon basin that are subordinate to the Salmon Wild and Scenic federal reserved water right<sup>2</sup>;
- Provide a Department employee, who is appointed as the Water District 170 watermaster, as a dedicated resource to assist sub-districts and provide more consistent and efficient administration of water rights in the Upper Salmon Basin and Water District 170.

11. Persons attending the hearing were provided opportunity to make oral statements for the record. In addition, the hearing officer held the record open through November 26, 2012, for the submittal of written comments.

12. No oral testimony was offered at the hearing. The Department did not receive any written comments from affected water right holders or other interested parties prior to the close of the comment period on November 26, 2012.

## CONCLUSIONS OF LAW

1. Idaho law declares all surface water, when in natural channels or springs or lakes, and all ground water within the State of Idaho to be the property of the state, whose duty it is to supervise the appropriation and allotment of the water to those diverting the same for beneficial use. *See* Idaho Code §§ 42-101, 42-103, and 42-226.

2. The Director, acting on behalf of the State of Idaho, has the statutory authority to control the appropriation and use of all surface and ground waters within the state in accordance

with, but not limited to, Idaho Code §§ 42-101, 42-103, 42-202(1), 42-220, 42-226, 42-237a.g., 42-351, and 42-602 et seq.

3. Idaho Code §§ 42-226 and 42-237a.g., assign the authority and responsibility to the Director for the administration of ground water rights in the state in accordance with the prior appropriation doctrine as established by Idaho law so as to protect prior surface and ground water rights.

4. The Director has responsibility for direction and control over the distribution of water in accordance with the prior appropriation doctrine as established by Idaho law within water districts to be accomplished through watermasters supervised by the Director, and subject to removal by the Director, as provided in chapter 6, title 42, Idaho Code.

5. Idaho Code § 42-604 mandates the Director to form water districts as necessary to properly administer uses of water from public streams, or other independent sources of water supply, for which a court having jurisdiction thereof has adjudicated the priorities of appropriation. *In re Idaho Dept. of Water Res. Amended Final Order Creating Water Dist. No. 170*, 148 Idaho 200, 211, 220 P.3d 318, 329 (2009). Efficient distribution of water, in accordance with the legislative mandate, requires that the Department implement sufficient administrative oversight to prevent conflicts from arising, where possible, and to furnish a framework of evenhanded oversight which allows for consistent planning by water users. *Id.* Implementation of the proposed actions described in Finding of Fact 8 is necessary for the efficient administration of water rights.

6. Idaho Code § 42-1417 provides that the district court having jurisdiction over a general water rights adjudication may authorize the interim administration of water rights pursuant to chapter 6, title 42, Idaho Code, prior to the entry of a final decree, in accordance with Director's Reports filed with the court, with or without modification by the court, or in accordance with partial decrees that have superseded the Director's Reports.

7. All of the water rights claimed in the SRBA and within the Department's Administrative Basins 71, 72 and 73 have been partially decreed or reported to the SRBA District Court.

8. Idaho Code § 42-111 provides that a water right permit may be issued, but shall not be required for appropriation of ground water for domestic uses.

9. Idaho Code § 42-113 provides that a water right permit may be issued, but shall not be required for appropriation of water for the in-stream watering of livestock.

10. Based on the above statutory authorities, the order of the SRBA District Court authorizing interim administration of water rights pursuant to chapter 6, title 42, Idaho Code, and the record in this proceeding, Water District No. 73 should be revised to include all surface and ground water rights in IDWR Administrative Basin 73, with the exception of de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113.

11. Based on the above statutory authorities, the order of the SRBA District Court authorizing interim administration of water rights pursuant to chapter 6, title 42, Idaho Code, and the record in this proceeding, Water District No. 170 should be revised to include all surface and ground water rights in Administrative Basins 71, 72 and 73, with the exception of de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113.

12. Water District No. 73 should be designated as a sub-district of Water District No. 170.

13. The sub-district as designated by this order is an organizational feature within Water District No. 170 to support a local watermaster that will, on behalf of and under the supervision of the Water District No. 170 Watermaster, perform the following duties within the sub-district:

- a. Administer and enforce water rights in priority;
- b. Measure and report the diversions under water rights;
- c. Curtail illegal diversions (i.e., any diversion without a water right or in excess of the elements or conditions of a water right);
- d. Curtail out-of-priority diversions determined by the Director to be causing injury to senior priority water rights if not covered by a stipulated agreement or a mitigation plan approved by the Director.

14. The following pertain to the sub-district as designated by this order:

- a. The water users will hold an annual meeting each spring prior to the start of the irrigation season on May 1 to adopt a budget, set the local watermaster's compensation, select a local watermaster, and adopt resolutions as necessary to govern operation of the sub-district.
- b. The local watermaster, with approval from the Director, will be appointed as a deputy watermaster of Water District No. 170. The deputy watermaster shall work pursuant to instructions of the Water District No. 170 Watermaster.
- c. Water rights within the sub-district shall not be subject to assessments from Water District No. 170 unless the Director determines that the sub-district is not providing for adequate distribution of water and the watermaster of Water District No. 170 is required to directly expend time or resources to deliver, measure, report, and/or regulate water in the sub-district.

## **ORDER**


IT IS HEREBY ORDERED that:

1. Water District No. 73 is revised to include all surface and ground water rights with the exception of de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113.

2. The boundaries of Water District No. 170 are revised to include all surface and ground water rights in Administrative Basins 71, 72 and 73, with the exception of de minimis stock water and domestic water rights as defined by Idaho Code §§ 42-111 and 42-1401A(11), and rights used for in-stream watering of livestock as defined by Idaho Code § 42-113.

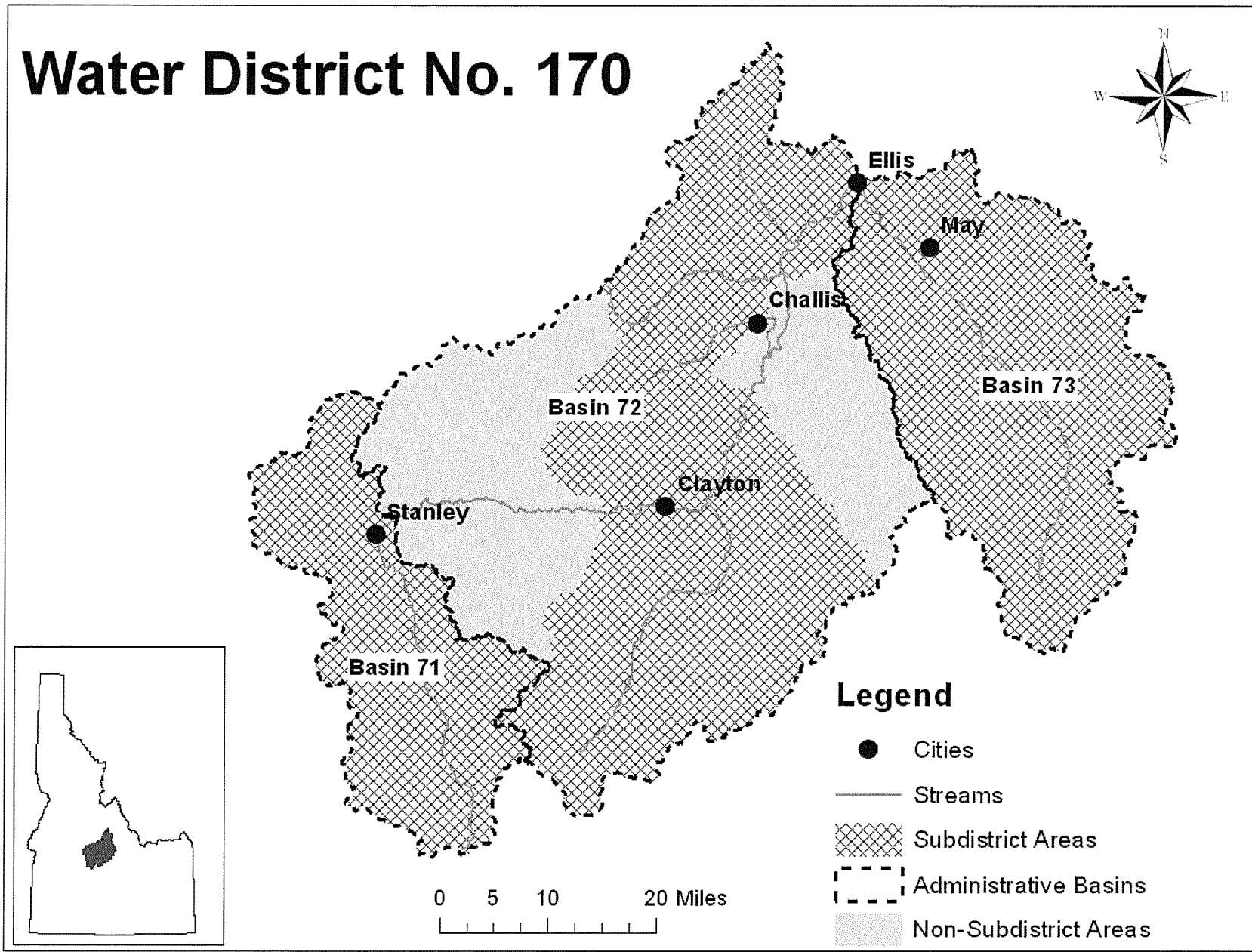
3. Water District No. 73 is hereby designated as a sub-district within Water District No. 170. The sub-district shall continue to meet annually to elect a watermaster, adopt a budget, and select an advisory committee. The sub-district shall be responsible for distribution of surface and ground water rights diverted from sources in IDWR Administrative Basin 73 that have been reported or partially decreed in the SRBA. For 2013, water right holders within the sub-district shall meet at a time and place as normally determined by the district.


