**RANGEN'S NOTICE OF
ACCPTANCE OF DELIVERY OF
WATER UNDER IGWA'S SECOND
MITIGATION PLAN**

**IN THE MATTER OF DISTRIBUTION OF
WATER TO WATER RIGHT NOS. 36-
02551 AND 36-07694
(RANGEN, INC.)**

WHEREAS, on June 20, 2014, the Director of the Idaho Department of Water Resources ("Director") issued an *Order Approving IGWA's Second Mitigation Plan; Order Lifting Stay Issued April 28, 2014; Second Amended Curtailment Order* ("Order");

WHEREAS, the Order conditionally approved IGWA's Second Mitigation Plan subject to IGWA doing the following: instituting preventive measures to address PKD, such as treating

the lower pool to kill the intermediate host, disinfecting pipelines that may contain PKD or the intermediate host, and covering the spring area; and designing and placing the diversion box at a location closer to the spring source to limit potential exposure to disease (*Order*, p. 18); and

WHEREAS, the Director Ordered IGWA to deliver the Tucker Springs water to Rangen no later than January 19, 2015 (*Order*, p. 18);

WHEREAS, over Rangen's objections to IGWA's Second Mitigation Plan, the Director Ordered Rangen to accept this water, and if not accepted, IGWA's mitigation obligation would be suspended (*Order*, p. 18);

NOW THEREFORE, RANGEN HEREBY PROVIDES NOTICE that Rangen will comply with the Director's Order and accept the water. Rangen will allow construction on its land related to placement of the delivery pipeline. By delivering this Notice, Rangen does not waive any right to seek judicial review of the Order, including, but not limited to, the right to raise issues concerning the presence of PKD in the Tucker Springs water, the risk of harm PKD presents to Rangen's Research Hatchery. Rangen does not waive any cause of action it may have against IGWA or the Department for damages caused by the delivery of water from Tucker Springs including, but not limited to, the introduction of disease or the failure of the water system.


