It is my understanding and expectation that Judge Wood will be immediately assigning the matter to you. Your prompt review and consideration would be greatly appreciated given the urgency of this matter and the likelihood that the Department's Water Master in Districts 130 and 140 may immediately begin curtailment efforts to enforce the Director's August 7, 2009 Curtailment Order by direct action pursuant to the water master general enforcement authority under I.C. §42-607, rather than following the enforcement procedure by notice and consent order pursuant to I.C. §42-1701 B.

We would respectfully request immediate issue of the Order for Temporary Stay with service upon all parties (preferably electronically) per the attached Certificate of Mailing, to remain in effect until the scheduled hearing on the Motion to Stay.
