COME NOW Respondents, the Idaho Department of Water Resources and the Director of the Idaho Department of Water Resources (“IDWR Respondents”), by and through their attorneys of record, and hereby move this Court to clarify its June 18, 2010 *Order Granting Extension of Time* (“Order”).

On June 16, 2010, counsel for Blue Lakes Trout Farm, Inc. and Clear Springs Foods, Inc. filed *Cross-Appellants/Respondents Joint Motion for Extension of Time for Filing Briefs* (“Joint

Motion”). The Joint Motion sought an extension of time for filing responsive and cross-appellant briefing until July 16, 2010. The Joint Motion accurately stated that IDWR Respondents would stipulate to the extension. In communication with opposing counsel, however, IDWR Respondents understood that the proposed date would apply to all respondent briefing. IDWR Respondents have similar commitments during the week of July 6, 2010.

On June 18, 2010, the Court issued its Order granting Respondent/Cross-Appellants’ Joint Motion. The Order stated that the Respondent/Cross-Appellant brief “shall be filed in this office on or before 7-16-10.” The Order went on to state, however, that “All other Respondents must file their briefs on or before 7-06-10.”

Based on IDWR Respondents’ understanding of the conversations resulting in the Joint Motion, IDWR Respondents request clarification of the Court’s Order regarding the filing deadline for its brief. IDWR Respondents’ respectfully request that its brief be filed with the Court no later than July 16, 2010.
