District, North Side Canal Company, and Twin Falls Canal Company will continue to take the testimony upon oral examination of MATTHEW WEAVER pursuant to Rule 30 and other applicable rules of the Idaho Rules of Civil Procedure, and Rule 523 of the Department's Rules of Procedure. The deposition will take place before a court reporter and Notary Public with the firm of M & M Court Reporting Service, on **Thursday, May 20, 2010 at 1:00 p.m.**, and continuing from day to day until completion, at the Idaho Department of Water Resources, 322 E. Front St., Boise, Idaho, at which time and place you are notified to appear and take part in such examination.

Pursuant to Idaho Rules of Civil Procedure 26, 30(b)(5), and 34, you are further instructed to bring to the deposition:

- (1) all documents relied upon, incorporated, produced, or utilized by you in connection with preparation of the Director's *Order Regarding IGWA's Mitigation Obligation* dated May 17, 2010.
- (2) all documents relied upon, incorporated, produced, or utilized by you in connection with preparation of the Director's *Order Approving Mitigation Credits Regarding SWC Delivery Call* dated May 17, 2010.
- (3) copies of all lease agreements, options, letters or other written confirmation, without redactions, submitted by IGWA to IDWR in connection with its *Supplement to IGWA's Notice of Secured Water* filed on May 14, 2010.
- (4) all documents regarding IDWR's analysis and evaluation of IGWA's *Notice of Water Secured* filed on May 13, 2010 and its *Supplement to IGWA's Notice of Secured Water* filed on May 14, 2010.

- (5) copies of any correspondence between IGWA and IDWR and/or Water District 01 regarding any lease agreements, options, letters or other written confirmation related to storage water in the Upper Snake River Basin since January 1, 2005, including the letter and attachments sent from Randy Budge to Lyle Swank dated June 29, 2009.


