

In July 2010, Petitioners filed *Petitions for Judicial Review* in the above-captioned matter, seeking judicial review of two final orders issued by the Director of the Idaho Department of Water Resources. On August 3, 2010, this Court issued a *Procedural Order Governing Judicial Review of Final Orders of Director of Idaho Department of Water Resources* (“*Procedural Order*”). Among other things, the *Procedural Order* scheduled the oral argument on the *Petitions* to be heard on Friday, February 11, 2011 at 1:30 p.m. On October 21, 2010, at the request of IDWR, this Court issued an *Order* extending the time set forth in the *Procedural Order* for IDWR to lodge the settled transcript and record with this Court. As a result of the extension, the February 11, 2011 date for oral argument on the *Petitions* is no longer viable.

Therefore, date for oral argument on the *Petitions* is amended as follows:

**Oral Argument, Telephonic and Video Teleconferencing: Oral argument will be heard on Monday, March 14, 2011, at 1:30 p.m. (Mountain Time) at the Snake River Basin Adjudication District Court, 253 3<sup>rd</sup> Avenue North, Twin Falls, Idaho. Telephone participation will be available by dialing 1-215-446-0193 and entering 406128# when prompted. Video teleconferencing (“VTC”) will also be available by appearing at the Idaho Department of Water Resources, Idaho Water Center, 322 E. Front St., Conference Rm. B, Boise, Idaho. Parties should refer to the *Administrative Order Adopting Procedures for the Implementation of the Idaho Supreme Court Administrative Order Dated December 9, 2009* issued by this Court on July 1, 2010, regarding protocol for telephone and VTC participation. The form and order of argument shall be governed by I.A.R. 37.**
