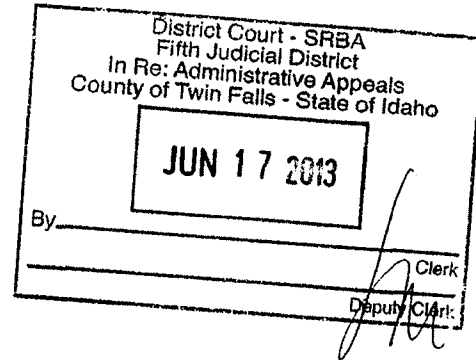

TWIN FALLS CANAL COMPANY



In light of the agreement and for the purposes of judicial economy, IDWR and the other parties to this proceeding request that this Court stay all proceedings in the above-captioned matter. The parties reserve all rights with respect to this case and pending requests, and nothing in this motion or the terms of the stay shall be used against any party in any future proceedings.

The parties request that this matter remain stayed until a decision has been issued by the Idaho Supreme Court in the SWC Supreme Court Appeal, Case NO. 38193-2010. Within thirty (30) days of a decision in the SWC Supreme Court Appeal, the parties will contact this Court regarding a status and scheduling conference.


