**ORDER GRANTING MOTIONS
 TO CONSOLIDATE**

On October 30, 2013, members of the Surface Water Coalition¹ filed *Motions to Consolidate* in Twin Falls County Case Nos. 2012-2096, 2013-2305, 2013-4417 and Lincoln County Case No. 2013-155. The *Motions* request that this Court consolidate the aforementioned matters into Gooding County Case No. 2010-382 on the grounds that they arise out of the same events, rely on the same facts and involve common questions of law and fact.² On November 1, 2013, the Idaho Department of Water Resources, the City of Pocatello and the Idaho Ground Water Appropriators, Inc. filed a *Joint Response to Surface Water Coalition's Motion to Consolidate*, wherein they agreed that the aforementioned matters should be consolidated into Gooding County Case No. 2010-382. Therefore, all the parties jointly support the *Motions to Consolidate*.


The Court notes that although the *Motions to Consolidate* are filed in contravention of this Court's *Orders* staying all proceedings in Twin Falls County Case Nos. 2012-2096, 2013-2305, Lincoln County Case No. 2013-155 and Gooding County Case No. 2010-382, the Court will consider the *Motions* notwithstanding the imposed stays since all the parties jointly support the *Motions*. However, this Court's stay *Orders* previously entered in those matters remain in place pursuant to this Court's *Order Denying Motions to Lift Stay* entered contemporaneously herewith.

THEREFORE, IT IS ORDERED that Twin Falls County Case No. 2012-2096, 2013-2305, 2013-4417 and Lincoln County Case No. 2013-155 are hereby consolidated into Gooding County Case No. CV-2010-382.

¹ The term Surface Water Coalition refers collectively to Petitioners A&B Irrigation District, American Falls Reservoir District #2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company and Twin Falls Canal Company.

² The Court notes that on July 29, 2010, the Court entered an *Order* consolidating Gooding County Cases CV-2010-383, CV-2010-384, CV-2010-387, CV-2010-388, and Twin Falls County Case CV-2010-3403 into Gooding County Case CV-2010-382.


