3. Attached hereto as Exhibit A is a true and correct copy of email correspondence relevant to the Motion To Vacate Status Conference.

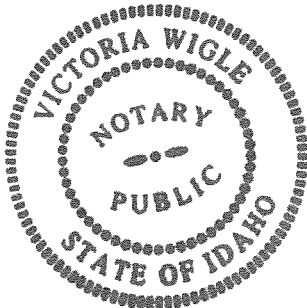
