I have reviewed physical file for permit 1-10609. I found that the physical file doesn't contain a print-out of the 813-page POU listing of interest to you. So, it is unlikely that water rights personnel made any changes to the document that your office provided. I am assuming that the water rights section received Place of Use 1-10609 in digital form and that it was imported as a digital item into our document management system, (DOCs), where it remains in digital form but now is available for anyone to view. The person who completed the import task is not in the office today.
