Comes now the U.S. Fish and Wildlife Service (Fish and Wildlife Service) and protests, pursuant to Idaho Code §42-203A, the applications of the Idaho Water Resource Board (Applicant) for water rights, nos. 01-07131, 01-07132, 01-07133, 01-07134, 01-07135, 01-07136, 01-07137, 01-07138, 01-07139, 01-07140, 01-07141, 02-07473, 02-07474, 21-07574, 21-07575, 21-07576, 21-07577, 21-07578, 21-07579, 21-07580. Applicant seeks to appropriate water from the Snake River, Henry's Fork of the Snake River, and Fall River throughout the year when water is available.

This protest is filed upon the grounds and for the reason that the proposed change may injure the the water rights of the Fish and Wildlife Service, including but not limited to the federal reserved water rights for the Deer Flat National Wildlife Refuge, and/or conflict with the local public interest, including but not limited to negatively impacting the fish and wildlife resources and habitat, aquatic life, or water quality of the Snake River and/or threatened or endangered species. The Fish and Wildlife has not had sufficient time to fully research the proposed applications and potential impacts.

The Fish and Wildlife Service submits herein the filing fee of \$25, as directed in the Notice of Application for Water Right, and requests that the subject applications be denied for the reasons described above.


