Specifically, discussion will focus on the Baseline Bypass Canal and Extension Bypass Canal saved water rights.

HISTORY: Last year the Department received a request of the watermaster for direction on delivering "saved water rights" on the Big Wood River. On July 16, 2002, a meeting was held with some water users and the watermaster in an effort to identify and understand issues concerning delivery of saved rights on the Baseline Bypass Canal and Extension Bypass Canal. After the meeting a letter dated August 6th, 2002, was sent to the watermaster providing instruction as to how these "saved water rights" are to be delivered. (Copy attached)

Apparently the watermaster continues to field questions as to how these rights are to be delivered. With prospects of continued poor water availability this year and continued questions the meeting above has been scheduled to address delivery of these rights.
