




Counts of Water Rights



Note: If slides are printed in greyscale, all Graphs should be read in clockwise order in relation to their legends.


Reservoir Refill Objections to LCDR

46 Objections to 7 Recommendations (Prior to Consolidation)




Basin 01 – Irrigation and Other Water Rights for Which Objections are Unresolved

BOR Reservoirs




Basin 21 – Irrigation and Other Water Rights for Which Objections are Unresolved







December 2016 CSRBA Claims Summary (Claims to be reported to the Court)




Federal Reserved Claims Before the Court


