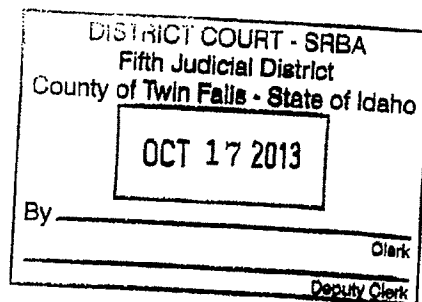

Findings of Fact

On August 15, 2006, the Director of the Idaho Department of Water Resources filed his *Part I Director's Report, Irrigation & Other Uses, IDWR Basin 03*. The Director recommended the following general provisions:

The following water rights from the following sources of water in Basin 03 shall be administered separately from all other water rights in Basin 03 in accordance with the prior appropriation doctrine as established by Idaho law:


