

BASIN 75 GENERAL PROVISIONS

The Director of the Idaho Department of Water Resources recommends to the Snake River Basin Adjudication District Court that the following general provisions be included in the decree determining rights to water from Basin 75.

1. The following water rights from the following sources of water in Basin 75 shall be administered separately from all other water rights in Basin 75 in accordance with the prior appropriation doctrine as established by Idaho law:

Findings of Fact

On January 11, 2007, the Director of the Idaho Department of Water Resources filed his *Part I Director's Report, Irrigation & Other Uses, Reporting Area 23, Basin 75*. The Director recommended the following general provisions:


