If any member disagrees with the hand or written ballot vote, a credentials committee can be called for and members will then vote by dollars of assessment based on the previous five years' water use (as per Idaho Code 42-605(4)). You must have a financial interest (lessee) with an accompanying letter/form from the owner (lessor) to vote someone else's water.
