The clerk’s record prepared in this matter was served on the parties on February 12, 2015. On March 12, 2015, Objections to the clerk’s record were filed by the A&B Irrigation District, American Falls Reservoir District #2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company and Twin Falls Canal (collectively, “Surface Water Coalition”) and the Idaho Ground Water Appropriators, Inc. (“IGWA”). Both Objections assert that the clerk’s record should be corrected to include the addition of various documents identified therein. A hearing on the Objections was held before this Court on April 1, 2015. At the hearing, IGWA orally amended its Objection to withdraw and remove eight of the twelve documents it requested be added to the clerk’s record. No party opposed the requests for additional documents made by either the Surface Water Coalition or IGWA. Therefore, after reviewing the file, the Court in an exercise of its discretion directed that the clerk’s record in this matter be supplemented with the documents identified in the Objections.

Therefore, IT IS ORDERED, that the clerk’s record in this matter be supplemented with the addition of the documents identified by the Surface Water Coalition in its Objection dated March 12, 2015.

IT IS FURTHER ORDERED that the clerk’s record in this matter be supplemented with the addition of the documents identified by IGWA in its Objection, as amended by IGWA at the April 1, 2015, hearing.
