The City of Pocatello ("Pocatello"), by and through its counsel, White & Jankowski, LLP, hereby petitions to be designated as a "Respondent" in the above captioned proceeding, pursuant to the Rules of Procedure of the Idaho Department of Water Resources. IDAPA § 37.01.01.

1-8) / Motion to Authorize Discovery ("SWC's Petition"). On May 9, 2012, the Director denied SWC's Petition.


Rule 154 of Department's Rules of Procedure defines "respondents" as "[p]ersons against whom complaints are filed or about whom investigations are initiated." IDAPA 37.01.01.154. Pocatello is a municipal corporation of the State of Idaho which diverts its municipal water supply from wells in the Eastern Snake Plan Aquifer within Water District 120. Pocatello also owns and operates associated surface water rights, including rights to water stored in Palisade Reservoir. Pocatello has been and is a party to the proceedings which originated from the Director's September 5, 2008 Final Order as a result of the SWC's Delivery Call. Any changes to the Director's April 13, 2012 Final Order which might result from the SWC's Petition are likely to materially affect Pocatello, as Pocatello's ground water supply may become the subject of curtailment orders. Because the above captioned proceedings will involve investigations into injury which the SWC alleges is being caused by junior water users, Pocatello is a "respondent" under Rule 154. Accordingly, Pocatello requests that it be designated as a respondent and permitted to participate in the above captioned matters.


