**REASONS FOR REQUEST**


On September 26, 2014, the Honorable Eric J. Wildman, Dist. Judge of the Fifth Jud. District, Gooding County entered a *Memorandum Decision and Order on Petitions for Judicial Review* (“SWC 382 Decision”) and entered *Judgment* in the consolidated Gooding County Case No. CV-2010-382 relative to six Petitions for Judicial Review on the Methodology and As-Applied Orders. Subsequently, the Petition for Rehearing and Motion to Alter and Amend Judgment were denied by the court on November 17, 2014.

In its decision, the Court remanded the Consolidated 382 Case to the Director “for further proceedings as necessary consistent with this decision”. See SWC 382 Decision at 48.

IGWA hereby respectfully requests the Director to schedule a Status Conference. Such conference will give opportunity to the parties to discuss issues implicated by the court’s SWC 382 Decision, procedural matters (if necessary), and any other matters which the Director deems appropriate and required to proceed on remand.
