RE: Notice of Curtailment of Ground Water Rights with Priority Dates Junior to June 20, 1989—Surface Water Coalition Delivery Call

Dear Water Right Holder,


You are receiving this letter because you are the holder of one or more ground water rights subject to the attached curtailment order recently issued by the Idaho Department of Water Resources ("Department"). Specifically, you hold ground water rights that are listed in Attachment C and Attachment D to the curtailment order.

With respect to your affected ground water rights listed in Attachment C, because you are also a ground water user in good standing with a ground water district member of the Idaho Ground Water Appropriators, Inc. ("IGWA"), your ground water rights listed in Attachment C are protected from curtailment by IGWA's approved March 9, 2016, mitigation plan. Your ground water rights listed in Attachment C will continue to be protected from curtailment so long as you remain in good standing with a member ground water district participating in the mitigation plan and the obligations identified in the plan continue to be met. See IDAPA 37.03.11.040.05.

With respect to your affected ground water rights listed in Attachment D, at 12:01 a.m. on or before February 2, 2017, you shall cease diversion and use of ground water pursuant to those right until otherwise notified by the Department. To avoid curtailment of your ground water rights listed in Attachment D, you may participate in an approved mitigation plan (such as the mitigation plan filed by the Idaho Ground Water Appropriators, Inc.) and shall have fifteen days to join, solely for mitigation purposes, the ground water district situated nearest the lands to which the water rights are appurtenant. See H.B. No. 737 (*Act Relating to the Administration of Ground Water Rights Within the Eastern Snake River Plain*, ch. 356, 2006, Idaho Sess. Laws 1089) and Idaho Code § 42-5259. You may also submit a proposed mitigation plan in accordance with the Department's Conjunctive Management Rule 43. See IDAPA 37.03.11.043. Upon receipt of a proposed mitigation plan, the Department will publish notice for two successive weeks, allow ten days for the filing of protests, and hold a hearing as necessary to determine whether the proposed plan will mitigate injury to the Surface Water Coalition caused by the ground water right at issue. If you do not participate in an approved mitigation plan by February 2, 2017, your ground water rights listed in Attachment D will be curtailed.
