 RESPONSE TO SPRING USERS'  
 JOINT PETITION FOR  
 CLARIFICATION**

COME NOW Idaho Ground Water Appropriators, Inc., North Snake Ground Water District, and Magic Valley Ground Water District (collectively "IGWA"), through counsel, and file this Notice of Intent to File Response to the Spring Users' Joint Petition for Clarification pursuant to IDAPA 37.01.01.270.02.

The Hearing Officer issued his *Responses to Petitions for Reconsideration and Clarification and Dairymens' Stipulated Agreement* on February 29, 2008 (the "Response Order"). The Response

Order modified portions of the *Opinion Constituting Findings of Fact, Conclusions of Law and Recommendation* filed January 11, 2008 (the “Recommended Order”). On March 12, 2008, the Spring Users’ filed the *Spring Users’ Joint Petition for Clarification* (the “Petition”). The Petition appears to be akin to a motion for reconsideration of the Response Order under Rule 720.01.a. IGWA intends to respond to the Petition within the time provided in Rule 270.02. Further, IGWA understands that the Petition tolls the time for the filing of exceptions to the Recommended Order and Response Order under Rule 720.01.b until such time that the Petition has been disposed of as provided in Rule 720.01.a. To the extent that this understanding is incorrect, IGWA requests a reasonable time to file exceptions to the Recommended Order and Response Order as provided under Rule 720.02.b.
