Pursuant to the arrangement agreed upon at the August 8, 2011, scheduling conference, below is a list of information that we are requesting from the Department and Department staff on behalf of the Idaho Ground Water Appropriators, Inc.

- All data sets, model files and related documents generated or used in the analysis of the Jones delivery call described in the Director's Order of July 29, 2005, denying the Jones delivery call.
- All data sets, model files and related documents generated or used in any analysis of the 2011 Jones' delivery call, Weatherby Springs, Three Springs, and Hoagland Tunnel or the Thousands Springs to Malad reach of the Snake River.
- All historical records of measured water flows in the Jones' facility, including discharges, diversions and bypasses at each spring outlet for which the Jones' facility has a water right.

- All correspondence between the Department and owners/operators of the Jones' facility, John W. Jones and Deloris D. Jones.
- All records and documents associated with any wells, well pumps, groundwater production, and groundwater quality located within one mile of the spring source for water right no. 36-7071.
- All documents and records associated with geologic, hydrologic and hydrogeologic investigations within two miles of the spring source for water right no. 36-7071.

We would also like you to verify that the water right files available online for water right no. 36-7071 are complete and contain all permits, licenses and decrees and relative to the water right at issue, including all related documentation and field inspection and verification reports made by the Department. If the online water right files are not complete, please provide information on where the complete files are and when they can be inspected and copied.

We appreciate your prompt attention to this matter and please let us know if you have any questions.
