

POCATELLO AND IGWA'S SECOND MOTION TO ISSUE SUBPOENAS DUCES TECUM

1. The parties have cooperated to schedule the continued deposition of Doug Ramsey.
2. Counsel for Rangen accepted service of Notice of Deposition, and such notice was served on October 29, 2012.
3. Pocatello and IGWA also desire that certain documents be made available for examination at the deposition, identified in the attached subpoena duces tecum.
4. Idaho Rule of Civil Procedure 30 provides for the issuance of a subpoena duces tecum to require the production of documents at deposition. I.R.C.P. 30(b)(1).
5. IDWR "may issue subpoenas upon a party's motion or upon its own initiative." IDAPA 37.01.01.525.
6. Pocatello and IGWA respectfully request that the Director issue the attached subpoena for Doug Ramsey.


