SCHEDULING ORDER****

On November 14, 2012, a Status/Scheduling Conference was held wherein the parties requested that the hearing schedule be amended. The parties have communicated and are in full agreement to amend the schedule as follows:

- **Dec. 21, 2012** – Opening expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- **Feb. 1, 2013** – Rebuttal expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- **Feb. 11 – 22, 2013** – Dates for expert depositions.
- **Feb. 20, 2013** – IDWR staff memo due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- **Feb. 25 - 28, 2013** – IDWR staff depositions.
- **March 8, 2013** – Dispositive motions deadline.
- **March 22, 2013** – Responses to staff memo due and Dispositive motions response briefs due.

- **March 29, 2013** – Dispositive motions reply briefs due.
- **April 3, 2013** – Hearing on dispositive motions.
- **April 8, 2013** – Witness lists and exhibits exchanged.
- **April 19, 2013** – Pre-hearing briefs due.
- **April 22, 2013** – Pre-hearing conference.
- **May 1, 2013** – Hearing begins.
- **May 15, 2013** – Hearing ends.

**ORDER**

Based upon the foregoing, IT IS HEREBY ORDERED that the above amended schedule is ADOPTED.


