On January 25, 2013, the Idaho Ground Water Appropriators, Inc. (“IGWA”) filed a *Request for Modification of Order Granting Motion to Extend Deadline* (“Motion”). The motion asks the Director of the Idaho Department of Water Resources to extend the deadline for all parties, not only IGWA, to respond to Rangen, Inc.’s (“Rangen”) *Motion for Partial Summary Judgment Re: Material Injury* to February 5, 2013. IGWA indicates that this was the intended agreement between all parties, including Rangen.

IT IS ORDERED, that the time for all parties to respond to Rangen’s pending partial motion for summary judgment is extended to February 5, 2013.
