On January 29, 2013, the parties in the Rangen, Inc. Delivery Call stipulated and agreed to modify certain dates presently outlined in the Third Amended Scheduling Order, dated November 21, 2012. The following schedule shall now govern this proceeding:

- **Feb. 8, 2013** – Rebuttal expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- **Feb. 19 – March 8, 2013** – Expert Witness Depositions (parties on their own have agreed to dates and times).
- **Feb. 27, 2013** – IDWR staff memo due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- **March 8, 2013** – Dispositive motions deadline.
- **March 11 – 15, 2013** – IDWR Staff Depositions at the IDWR, State office, 322 E. Front St., Boise.
- **March 22, 2013** – Responses to staff memo due and dispositive motions response briefs due.
- **March 29, 2013** – Dispositive motions reply briefs due.

- **April 3, 2013** – Hearing on dispositive motions.
- **April 8, 2013** – Witness lists and exhibits exchanged.
- **April 19, 2013** – Pre-hearing briefs due.
- **April 22, 2013** – Pre-hearing conference.
- **May 1, 2013** – Hearing begins.
- **May 15, 2013** – Hearing ends.
