On February 7, 2013, Rangen, Inc. ("Rangen") fax filed with the Director of the Idaho Department of Water Resources ("Director") a *Request for Emergency Status Conference* ("Request"). In addition to requesting an emergency status conference with the Director, Rangen also seeks the suspension of the deadline for the filing of rebuttal expert witness reports. On the same day, the Idaho Ground Water Appropriators, Inc. ("IGWA") and the City of Pocatello ("Pocatello") filed responses to Rangen's Request. IGWA and Pocatello do not oppose Rangen's request for an emergency status conference but do oppose the suspension of the deadline for the filing of rebuttal expert witness reports.

**NOTICE OF EMERGENCY STATUS CONFERENCE**

The Director will grant Rangen's request to hold an emergency status conference and hereby notifies the parties to the above captioned proceeding that a status conference will be held on **February 8, 2013 at 1:00 P.M.** (Mountain Standard Time) at the **Idaho Department of Water Resources, State Office, 322 East Front St., 6<sup>th</sup> Floor, Boise, Idaho.**

Given the opposition to Rangen's request to suspend the expert rebuttal report deadline, the Director will not grant Rangen's request to suspend the deadline for submission of expert reports.


