Please take notice, that counsel for the City of Pocatello will take the testimony upon oral examination of **CHARLES BROCKWAY** pursuant to Rule 30, I.R.C.P., other applicable rules of the Idaho Rules of Civil Procedure and applicable rules of the Idaho Department of Water Resources Procedural Rules, IDAPA 37.01.01. The continued deposition will take place before a court reporter and Notary Public with the firm of M&M Court Reporting Service or other duly


qualified person in the above-captioned matter. Said deposition will commence on a **trailing docket on May 1st 2013, following the first day of hearing in this matter**, and will continue from day to day until completion, at the **Offices of the Idaho Department of Water Resources, located at 322 E. Pursuant to Idaho Rules of Civil Procedure 26, 30(b)(5) and 34, you are further instructed to bring to the deposition the following materials:

2. All notes or other documents related to communications between Brockway Engineering and Rangen staff regarding the preparation of the Supplemental Data.
3. All notes or other documents related to communications between Brockway Engineering and Rangen's legal counsel regarding the preparation of the Supplemental Data.
4. Field notes and flow measurement notes by Brockway and Sullivan
5. Any and all investigations of the permitted, licensed, claimed, or decreed attributes of the Rangen water rights including, but not limited to the source, point of diversion, place of use, and priority date.
6. Evidence of the original construction and any and all subsequent modifications of the points of diversion, water collection, and water conveyance facilities.
7. Any and all communications with IDWR regarding the attributes of the Rangen water rights.
