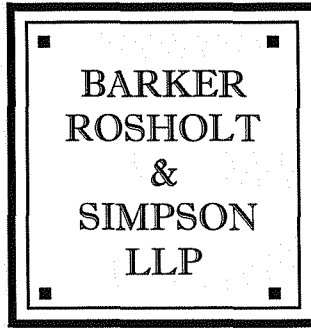


Dear Director:
