On March 9, 2010, the A&B Irrigation District ("A&B"), by and through its attorneys, Travis L. Thompson of the firm Barker, Rosholt & Simpson, LLP, filed a *Motion for Order Authorizing Discovery & to Shorten Response Deadline* ("Motion") with the Idaho Department of Water Resources ("IDWR"). No responses have been filed in regard to the Motion. The Motion seeks authorization for discovery and requests that discovery requests be answered by March 26, 2010. A hearing in the above-captioned matter is scheduled to commence on April 7, 2010.

ORDER

IT IS HEREBY ORDERED that the parties to this matter are authorized to engage in discovery.

IT IS FURTHER ORDERED that discovery is limited to testimony and information that will be presented at the hearing.

IT IS FURTHER ORDERED that, given the hearing on this matter is scheduled to begin on April 7, 2010, responses to discovery must be answered by March 26, 2010.

IT IS FURTHER ORDERED that the parties shall exchange exhibits and witness lists, and provide a copy of proposed exhibits to the hearing officer on or before April 5, 2010.
