**Re: Notice Regarding Participation in a Ground Water District or Irrigation District as a Nonmember for Mitigation Purposes Only, Blue Lakes Delivery Call, Water District Nos. 34, 130 and 140.**

**Affected Right No(s): <rights>**

Dear Water Right Holder:

This letter provides notice pursuant to 2006 Idaho Session Laws 1089 that you may need to join a ground water district or irrigation district solely for mitigation purposes to ensure that the above referenced ground water rights are included in a 2008 mitigation or replacement water plan approved by the Director of the Idaho Department of Water Resources (Director or Department). On July 1, 2008, the Director issued an Order Approving the Idaho Ground Water Appropriators, Inc. (IGWA) 2008 Replacement Water Plan for the Blue Lakes Delivery Call. The 2008 IGWA replacement plan provides direct delivery of an additional 10 cfs of spring flow from Alpheus Creek to Blue Lakes Trout Farm Inc. (Blue Lakes) to mitigate for injury to Blue Lakes' December 28, 1973 priority water right from Alpheus Creek caused by pumping of junior priority ground water rights located within portions of Water Districts 130, 140 and 34. The 10 cfs additional flow was acquired by the State of Idaho and Idaho Water Resource Board's (Board) purchase of a 1964 priority water right from Alpheus Creek formerly held by Pristine Springs, Inc. The Pristine Springs right is held by the Board in Trust for the benefit and use by IGWA participating ground water districts and irrigation districts. The approved replacement plan provides relief to holders of ground water rights junior to June 9, 1975<sup>1</sup> and located within the Blue Lakes delivery call area from potential curtailment under the Blue Lakes call during the 2008 irrigation season if the right holders are members of ground water districts or irrigation districts participating in the IGWA plan.

**The recipient(s) of this notice must be able to provide evidence by August 15, 2008 that the above referenced ground water right(s) is included in a ground water district or irrigation district that is a participating in IGWA's 2008 replacement plan.**

Currently, the North Snake and Magic Valley Ground Water Districts are the only IGWA replacement plan member districts. The Department understands that the Southwest and Goose Creek Irrigation Districts are holding elections on August 5, 2008 to consider their respective district's participation and costs in the IGWA plan. The Department further understands that the Carey Valley Ground Water District is also considering participation in the IGWA replacement plan. These latter districts must provide evidence to the Department on or before August 8, 2008 regarding their participation in the IGWA plan. If these districts do not participate in the IGWA plan, then affected


right holders within these districts must petition to join one of the two IGWA member ground water districts referenced in this letter. Petitions to join a ground water district should be filed with the ground water district located nearest the lands to which your right(s) is appurtenant.

Recipients of this notice whose above referenced water right(s) is located outside the boundaries of any of the above ground water or irrigation districts are still required to participate in mitigation. Holders of affected rights must petition to join the closest district listed above which is participating in the IGWA replacement plan.

The Director of the Department may take any appropriate action within his authority to assure that recipients of this letter and the right or rights identified herein are covered by an approved mitigation plan. If your right(s) identified in this notice have already been included in a ground water district for mitigation purposes or is included in another approved mitigation plan, then please contact the water district watermaster directly or have the ground water district or other mitigating entity contact the watermaster with verification regarding inclusion of your rights. Generally, a petition for annexation or inclusion of rights in the ground water district for mitigation purposes is acceptable.

A copy of the Director's Order Approving the 2008 IGWA Replacement Water Plan is being served to all recipients of this notice with water rights located in Water District No. 140. This order and all other pertinent orders and correspondence concerning the Thousand Springs delivery calls, including a map of the Blue Lakes delivery call area with ground water and irrigation district locations can be found on the IDWR website at: <http://www.idwr.idaho.gov/Calls/Spring%20Users%20Calls/default.htm> The Blue Lakes delivery call was made under the Department's Rules for Conjunctive Management of Surface and Ground Water Sources (IDAPA 37.03.11). This notice has been sent pursuant to the Director's Order of May 19, 2005 and July 1, 2008, issued in response to the Blue Lakes Trout Farm delivery calls, and Legislative House Bill No. 737, 2006 Idaho Session Laws 1089, adopted by the Idaho Legislature in 2006.
