On March 10, 2010, the Director of the Department of Water Resources ("Director" or "Department") issued a *Scheduling Order* in which the parties agreed to commence hearing on May 24, 2010, regarding the Idaho Ground Water Appropriators, Inc.'s ("IGWA") CM Rule 43 mitigation plan for the Surface Water Coalition ("SWC"). The hearing was scheduled to run from May 24, 2010 through May 26, 2010.

On May 24, 2010, the Director will conduct a hearing on 2008 data in the Director's *Final Order Regarding Methodology for Determining Reasonable In-Season Demand and Reasonable Carryover* (April 8, 2010) ("Methodology Order"). Immediately following that hearing, the Director will hold a hearing on whether the Director's *Order Regarding April 2010 Forecast Supply (Methodology Steps 3 & 4)* (April 29, 2010) followed Steps 3 and 4 of the Methodology Order.

Notice is hereby given that hearing on IGWA's CM Rule 43 mitigation plan for the SWC shall commence immediately following completion of the above hearings. Hearing on IGWA's CM Rule 43 mitigation plan shall run from day-to-day until completion.
