
Aquifer Enhancement Activity Credit”) filed with the Idaho Department of Water Resources on February 26, 2015:

1. Rangen has no objection to credit based upon aquifer enhancement activity/voluntary curtailment that occurred in the past. It is Rangen’s understanding that the analysis performed by Staff was conducted with the assumption that no such activities would occur in the future. Based upon this understanding, credit for 1.1 cfs for the period from April 1, 2015 to March 31, 2016 is appropriate.

2. All such credits should be allocated to water rights from the Curren Tunnel in order of priority.


