**ORDER AUTHORIZING  
DISCOVERY**

On September 16, 2014, the Director (“Director”) of the Idaho Department of Resources (“Department”) received a *Stipulation and Joint Motion to Authorize Discovery* (“Joint Motion”). In the Joint Motion, Rangen, Inc. (“Rangen”), and the Idaho Ground Water Appropriators, Inc. (“IGWA”), move the Director, pursuant to the Department’s Rule of Procedure 521, for an order authorizing discovery in this proceeding. Rangen and IGWA further agreed to submit a request for a scheduling order after they have consulted with any additional protestants in this matter following the protest deadline of September 22, 2014.<sup>1</sup>

**ORDER**

IT IS HEREBY ORDERED that parties to the above-titled mitigation plan are authorized to engage in discovery.

IT IS FURTHER ORDERED that following the protest deadline of September 22, 2014, Rangen and IGWA shall confer with any additional protestants and submit a proposed scheduling order to the Director for consideration.
