
COME NOW, the Petitioners, NORTH SIDE CANAL COMPANY and TWIN FALLS

Rule 74(b) of the Idaho Rules of Civil Procedure for an Alternative Write of Mandate
compelling the Respondents to void the September 5, 2007, *Notice of Intent to Issue License* and

close all protest or comment period *In the Matter of Licensing Water Right Permit No. 01-7011 in the Name of Twin Falls Canal Company and North Side Canal Company*, and to issue the Petitioners a license for their water right permit no. 01-7011, pursuant to the beneficial use examination received by Respondents on November 1, 1993, and the conditions on the existing water right permit no. 01-7011 in compliance with Idaho Code § 42-219, and to appear before the Court at a time a place certain, and show cause, in any they have, why they have not complied with the terms of the Alternative Writ of Mandate.
