Dear Director Tuthill:

I am writing this letter as President of the Idaho Dairymen's Association ("IDA") on behalf of its dairy members whose commercial stockwatering rights may be subject to potential curtailment under any of your Orders issued in response to pending delivery calls from the Surface Water Coalition ("SWC") or spring users in the Thousand Springs Reach.

IDA is organized under the provisions of Chapter 3, Title 30 as a non-profit cooperative association, its original certificate of incorporation was issued July 5, 1944. All dairy producers in Idaho are members of IDA and elect fellow dairy producers as their representative board members.

As you know, IDA has entered into a Mitigation Agreement with the SWC and certain spring users, including Clear Springs Foods. IDA has agreed to seek to obtain participation in the mitigation actions contemplated by that agreement by each of its members. Also, as you know, IDA has been actively meeting with its members and encouraging their participation. As of the date of this letter, IDA has obtained signatures from those persons/dairies indicated on the attached participation election forms.

Due to the large numbers of dairies involved, it has not been possible to contact or obtain signatures from all of our members who may wish to participate. I fully expect that others who have not yet been able to sign the participation election form, would have signed, but for the logistical problems involved and the shortness of time available. I therefore am notifying you that, under my authority as IDA's President, I am hereby making such participation election for each of IDA's members whose water rights may be subject to curtailment under the Department's pending Orders, but have not signed on the attached form, and notifying you that provided the Mitigation Agreement is approved by the Department as required by the Agreement's terms, IDA's intent is to obtain sufficient water in 2007 to satisfy the requirements of the Agreement with respect to these members' rights for 2007.
