On June 15, 2007, the Director of the Department of Water Resources (“Director” or “Department”) issued orders in the above-entitled matters curtailing junior priority ground water rights. *Order Curtailing Junior Priority Ground Water Rights (Blue Lakes Delivery Call)*; *Order Curtailing Junior Priority Ground Water Rights (Clear Springs, Snake River Farm Delivery Call)* (hereinafter “June 15 Orders”). The June 15 Orders were final orders of the Department. Because the June 15 Orders were issued before an opportunity for hearing, the Orders stated that any person aggrieved by the Orders would be entitled to a hearing before the Director to contest the actions pursuant to Idaho Code § 42-1701A(3).

Timely petitions for reconsideration were subsequently filed by Blue Lakes Trout Farm, Inc., Clear Springs Foods, Inc., Idaho Ground Water Appropriators, Inc., Hidden Valley Dairy Farm, operated by Afton and Perry Van Tassell, and Long View Dairy, operated by Bob and Kathleen Krucker.


**ORDER**


