
**IDAHO DAIRYMEN'S ASSOCIATION  
RESPONSE TO STIPULATION AND JOINT  
MOTION FOR RESCHEDULED HEARING  
AND ORDER**

The Idaho Dairymen's Association ("IDA"), through its counsel Givens Pursley LLP, hereby responds to the Stipulation and Joint Motion for Rescheduled Hearing and Order ("Stipulation") filed by Clear Springs Foods, Inc., Blue Lakes Trout Farm and IGWA. IDA joins in paragraphs 3 and 4 of the Stipulation, and takes no position with respect to the balance of the Stipulation concerning the proposed amended hearing schedule.

The foregoing notwithstanding, and due to the very time sensitive nature of IDA's, SWC's and Clear Springs pending Mitigation Agreement, IDA expressly does not concede that determination of the sufficiency of the mitigation proposed in its Mitigation Agreement can be postponed to coincide with either the current hearing schedule or the schedule proposed in the Stipulation. An expedited determination of that issue is necessary.
