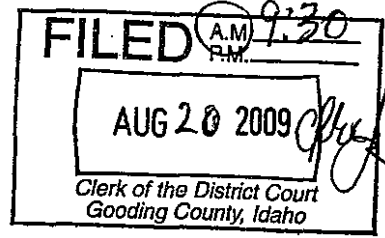

This Court issued its *Order on Petition for Judicial Review* in this matter on June 19, 2009. On July 10, 2009, Blue Lakes Trout Farms, Inc. and Clear Springs Foods, Inc. filed a *Joint Petition for Rehearing*. On July 13, 2009, the Ground Water Users also filed a *Petition for Rehearing*. Pursuant to Idaho Rule of Civil Procedure 84( r) and Idaho Appellate Rule 34( c), IT IS HEREBY ORDERED that the following briefing schedule applies:

1. **August 21, 2009:** Deadline for filing Petitioners' opening briefs.
2. **September 11, 2009:** Deadline for Respondent's brief.
3. **September 18, 2009:** Deadline for filing Petitioners' reply briefs.
4. **Oral Argument, September 29, 2009:** Oral argument will be heard at 10:00 a.m. at the Gooding County Courthouse, 624 Main Street, in Gooding, Idaho. **Telephone participation will be available by dialing 1-918-583-3445 and entering 406128 when prompted.**


