

TO: THE DISTRICT COURT AND PARTIES OF RECORD

YOU ARE HEREBY NOTIFIED, pursuant to I.R.C.P. 84(j), that the supplement to the agency record¹, having been prepared pursuant to I.R.C.P 84(f), is lodged with the agency for the purpose of settlement in accordance with I.R.C.P. 84(j). Since the issuance of the *Order Settling the Agency Transcript and Record* on December 17, 2010, there have been no additional hearings held in this matter before the agency, therefore no additional transcripts have been added to the record in this proceeding. This supplement contains the subsequent agency record up to the *Order Adopting IGWA's Amended Notice of Secured Water* issued on February 3, 2014.

¹ The agency record and transcript in this matter was originally lodged with the District Court on December 17, 2010. *Notice of Lodging Transcripts and Records with the District Court* (December 17, 2010). Subsequently, additional cases were consolidated with this case. Twin Falls County Case Nos. CV-2010-5520 and CV-2010-5946 were consolidated by separate orders titled *Order Consolidating Proceeding Into Gooding County Case No. CV-2010-382; Order Granting Motion for Stay*, both issued on January 3, 2011. Twin Falls County Case Nos. CV-2012-2096, CV-2013-2305, CV-2013-4417, and Lincoln County Case No. CV-2013-155 were consolidated with CV-2010-382 pursuant to the *Order Granting Motions to Consolidate* issued on November 12, 2013. This supplemental record is necessary because there are documents related to these subsequently consolidated cases that were not included in the previous record. To simplify the record for the Court and the Parties, the DVD being provided to the parties and the copies of the record that will be provided to the Court contain the agency record as lodged with the Court on December 17, 2010, plus the documents related to the subsequently consolidated cases.


A DVD containing the contents of the supplemental record is now available to the Petitioners at the agency's office and has been served by mail with a copy of this notice to the parties' attorneys of record. The actual preparation cost of the record is \$36.95 (.01 per page). The agency does not anticipate any further charges affiliated with the continued preparation of the record. However, the agency will inform Petitioners immediately should additional charges be incurred.

The parties have fourteen (14) days from the date of the mailing of this notice in which to file any objections to the transcript and record. If no objections are filed within that time, the record and transcript shall be deemed settled. The agency's decision on any objection timely filed along with all evidence, exhibits and written presentation of the objection shall be included in the record. Thereafter, the agency shall lodge the settled record with the district court pursuant to I.R.C.P. 84(k).


