Comes now, the City of Pocatello (“Pocatello”), by and through its counsel of record, and respectfully objects pursuant to Idaho Appellate Rule 29(a) to the clerk’s record filed in this matter.

The following document filed in Gooding County Case No. CV 2008-551, was listed on the clerk's index, bates range 10589-10602, but was not included on the discs from the department.




