On February 24, 2014, this Court issued an *Amended Procedural Order Governing Judicial Review of Final Orders of Director of Idaho Department of Water Resources* (“*Amended Procedural Order*”). Among other things, the *Amended Procedural Order* set forth the briefing schedule in the above-captioned matter and set an oral argument date of July 9, 2014 at 1:30 p.m. On May 8, 2014, the parties filed a *Joint Motion to Amend Oral Argument and Briefing Schedule*, wherein the parties jointly request that this Court (1) reschedule the oral argument in this matter to August 13, 2014, at 1:30 p.m., and (2) revise the briefing schedule as follows: Friday, June 13, 2014 – Petitioners’ briefs due; Friday, July 11, 2014 – Respondents’ briefs due; and Friday, August 1, 2014 – Reply briefs due. The *Joint Motion* is unopposed.

THEREFORE, THE FOLLOWING ARE HEREBY ORDERED:

1. The *Joint Motion to Amend Oral Argument and Briefing Schedule* is **hereby granted**.
2. The parties shall abide by the following briefing schedule in this matter:

 - Friday, July 11, 2014 – Respondents’ briefs due
 - Friday, August 1, 2014 – Reply briefs due
3. The oral argument previously set for July 9, 2014 is **hereby vacated**.

Notice is hereby given that oral argument will be heard on **August 13, 2014, at 1:30 p.m. (Mountain Time)** at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Telephone participation will be available by dialing 1-215-446-0193 and entering 406128# when prompted. Video teleconferencing (“VTC”) will also be available by appearing at the Idaho Department of Water Resources, Idaho Water Center, 322 E. Front St., Conference Rm. B, Boise, Idaho. Parties should refer to the *Procedural Order*

regarding protocol for telephone and VTC participation. The form and order of argument shall be governed by I.A.R. 37.
