I, GARRICK L. BAXTER, being first duly sworn upon oath, depose and say:


1. That I am a deputy attorney general and represent the Idaho Department of Water Resources (“IDWR”) in the above matter.

5. That I believe an extension of three (3) days, to and including July 14, 2014, is a reasonable and necessary extension.


6. That I have communicated this request to counsel for the other parties in this case and counsel has represented that the parties have no objection to the granting of the requested extension of time.


