On September 26, 2014, this Court entered a *Memorandum Decision and Order on Petitions for Judicial Review* and corresponding *Judgment* in the above-captioned matter. On October 10, 2014, the Surface Water Coalition<sup>1</sup> filed a *Joint Petition for Rehearing*. On that same date, the Respondents filed a *Motion to Alter or Amend Judgment*. On October 14, 2014, this Court entered a *Notice of Hearing* setting a hearing on the *Joint Petition for Rehearing* and *Motion to Alter or Amend Judgment* for October 30, 2014 at 1:30 p.m.

On October 17, 2014, the Idaho Ground Water Appropriators, Inc. (“IGWA”) filed a *Petition for Rehearing* and a *Motion to Continue Hearing*. The *Motion to Continue* asks this Court to vacate and reset the October 30, 2014, hearing to enable the Surface Water Coalition’s *Joint Petition for Rehearing*, the *Motion to Alter or Amend Judgment*, and IGWA’s *Petition for Rehearing* to be heard simultaneously. This Court agrees that hearing IGWA’s *Petition for Rehearing* along with the *Joint Petition for Rehearing* and *Motion to Alter or Amend Judgment* will expedite this matter and further the interests of the litigants as all three petitions seek rehearing on this Court’s September 26, 2014, *Memorandum Decision and Order* and *Judgment*.

THEREFORE, THE FOLLOWING ARE ORDERED:


1. IGWA’S *Motion to Continue Hearing* is hereby granted.
2. The oral argument set in this matter for October 30, 2014, is hereby vacated.
3. NOTICE IS HEREBY GIVEN that a hearing on the Surface Water Coalition’s *Joint Petition for Rehearing*, IDWR’s *Motion to Alter or Amend Judgment*, and IGWA’s *Petition for Rehearing* is set for **November 13, 2014, at 10:00 a.m.** (Mountain Time) at the Snake River Basin Adjudication District Court, 253 3<sup>rd</sup> Avenue North, Twin Falls, Idaho. However, no cell
